CALL FOR APPLICATIONS - PTE SUMMER DORMITORY

The Dormitory Department of the Student Services Centre of the University of Pécs (hereinafter referred to as: PTE HSZK KFO) announces today a call for applications for the summer dormitory service for the period between 1 July 2024 and 26 August 2024.

Applications are open to all students who have had dormitory membership/or on a summer internship during the academic year of 2023/2024. The summer residence service is available at the Balassa János Dormitory, for limited number of students.

For students whose dormitory applications for 2024/25 academic year were rejected, the summer accomodation will be available between 1 July 2024- 20 August 2024, while students who have received dormitory place for next semester can stay from 1 July 2024 until 26 August 2024- these students can move to their allocated dormitory after 26th of August.

Applications will be evaluated by the PTE HSZK KFO. The summer dormitory service fee is HUF 50,000 per person per month. In case of use for less than 20 days, 75% of the total monthly fee is payable. The fee for the summer dormitory service must be paid at the reception desk when moving in for the month of July and by 31 July for the month of August. The service includes room cleaning once a week during the period of occupancy, change of bed linen every 2 weeks on request.

The students will be informed about the success of their application, the allocated place, the occupancy of the place and the relocation by email after the application deadline.

The summer dormitory application can only be submitted via the Neptun education system between 8 May 2024 (Wednesday) 16:00 and 23 May 2024 (Thursday) 23:59. Applications after this deadline will not be accepted.

The PTE HSZK KFO may allocate temporary accommodation for the student within the summer residence during the summer residence period, which the student is obliged to accept, due to the maintenance and cleaning works necessary for the operation of the buildings.

When moving in, each student must declare in writing that he/she accepts the dormitory rules. By signing the move-in declaration, the student accepts disciplinary and compensation liability for any damage caused during the summer period.

<u>Please note that the application will be rejected without examination in the cases listed below:</u>

- In the case of outstanding fees owed to the dormitory at the time the application is examined
- In the 2023/2024 academic year, in the case of a report issued due to activating fire alarm, inappropriate use of the kitchen, making noise, causing damage, or not cleaning the room
- Failure or non-completion of the fire safety test in the 2023/2024 academic year

Applications will be assessed on the basis of the following criteria:

- a) social status (for students with permanent residence in Hungary)
- b) academic results

- c) sports club activities
- d) professional experience
- e) students not having a permanent address in Hungary

a.) Social status (for students with a permanent address in Hungary)

During the evaluation of the summer dormitory application, at the request of the student, the social points of the regular social scholarship application submitted in the spring semester of the 2023/2024 academic year, or the social points determined during the senior year dormitory application for the 2024/2025 academic year will be taken into account. The one with the higher score will be taken into account from the two application procedures.

b.) Academic results

When assessing the applicant's academic performance, the adjusted credit index of the last completed semester must be taken into account. The adjusted credit index is multiplied by 10 when calculating the number of points. There is nothing to be done by the applicant in relation to thiscriteria.

c.) Sport club activities

When submitting the application for a summer dormitory, the applicant must upload a certificate certified by a representative of the association, which clearly states the activity of the sports association during the summer dormitory.

d.) Professional practice

When submitting the application for summer dormitory, the applicant is required to upload an admission form for the internship, certified by the institutional coordinator, which clearly indicates the place and duration of the internship.

e.) Students who do not have a permanent address in Hungary

There is nothing to be done by the applicant in relation to these criteria.

The scoring system for the evaluation of proposals is set out in Annex 1 to this call for proposals.

SCORING GUIDE

a) Social situation score

The social status of the student shall be determined by the Committee of the University of Pécs on the basis of the points system and principles laid down in Annex 2/2 of the University of Pécs' Organisational and Operational Rules (hereinafter: OO), according to paragraph 7 (1) of Annex 3 of the OO. A maximum of 100 points may be obtained on a social basis.

b) Points awarded for the academic result

The number of points a student may receive for his/her academic results is determined in accordance with the provisions of Annex 3, Article 7, paragraphs (2) to (4) of the TJSZ. A maximum of 50 points may be obtained on an academic basis.

- c) Points for sport club activities
- **d)** In the case of submitting a document that complies with the certification procedure included in the call: 15 points. **Points awarded for professional practice**
- e) In the case of submitting a document that complies with the certification procedure included in the call: 25 points. Points awarded to students who do not have a permanent address in Hungary

If the permanent address recorded in the NEPTUN education system is outside of the territory of Hungary, the score available in this case is 20 points.
